- 8. Superintendent Report Written report was submitted prior to the meeting, Ms. Monroe also gave an update on the following topics:
  - A. DD Awareness Month Activities
    - The DD Awareness Month kick-off at the Courthouse was held on 3/6/23.
       The Commissioners presented Tanner Huff with a proclamation declaring March as DD Awareness Month. The event was well attended by individuals served, providers, and staff.
    - The Chili fest and Craft/Vendor Show was held on 3/11/2023. The event drew approximately 440 participants (not counting chili, craft/vendor participants, and volunteers). There were a variety of activities to participate in and individuals served participated in various capacities.
    - The Art For All mural project with Third and Center will be held on 3/23/2023 from 11 a.m. to 1 p.m. on the Ironton Riverfront.
    - The basketball game between Open Door School and Vern Riffe School (Scioto County) at Ironton High School will be held on Thursday, 3/30/23 at 10:30 a.m.
    - The Inclusive Egg Hunt with the Autism Project of Lawrence County and the Special Needs Youth Sportsmen will be held on Saturday, April 8, at the Lawrence County Fairgrounds from 12-2.
  - B. LCDD Awareness Campaign
    - Silfies Media has started their services. They recently presented a training for staff members involved in awareness and PR activities, and reviewed their awareness campaign plan. A new agency procedure was developed that will be implemented to assist with the assimilation of materials that Silfies can use to promote LCDD programs.
  - C. State Budget Updates
    - Testimony continues to advocate for the budget increase. The Governor's
      proposed budget includes an increase in the average hourly wage for private
      DSPs. While this increase is a move in the right direction, the coalition feels
      this not enough to address the workforce crisis. Ohio's DD Crisis Awareness
      Campaign.
  - D. Ohio DD Crisis Awareness Campaign
    - A handout from the DD Crisis Campaign was shared with the Board. To summarize, the DD direct service workforce crisis is impacting the availability of services to individuals with DD across the state. The DD Crisis Campaign is organized by a coalition of providers, OACB, OPRA, and other

stakeholders to advocate for an increase to the provider reimbursement rate in the next biennium budget.

# E. DODD Accreditation

LCDD received a one-year accreditation from DODD. There were no concerns noted regarding quality of services or health and safety. There were no citations in the MUI area. The citations received were primarily process-oriented, and leadership is working closely with DODD to make necessary adjustments. Additionally, new systems aimed at monitoring compliance-related tasks have been put into place. DODD has approved the plan of correction submitted.
